

Privacy Notice

How we respect privacy when we deal with personal information collected by our organisation

This Privacy Policy applies to information Guernsey SUP collects about individuals who interact with our organisation. It explains what personal information we collect and how we use it.

1. Personal data that we process

The following table explains the types of data we collect and the legal basis, under current data protection legislation, on which this data is processed.

Purpose	Data (key elements)	Basis
Enquiring about our services	Name, email, message, telephone number	Legitimate interests - it is necessary for us to read and store your message so that we can respond in the way that you would expect.
Engaging our services	Name, email, address, telephone, and information concerning your health and suitability to engage in our services	Legitimate interests-it is necessary for us to collect data to ensure you are physically fit enough to undertake the relevant services you wish to engage in. Consent-you have given your active consent and agree to the disclaimers signed.
Website functionality	Website activity collected through cookies	Legitimate interests - it is necessary for us to store a small amount of information, usually through cookies, to deliver functionality that you would expect, such as remembering the contents of your order before you have fully completed the process.

2. How we use your data

We will only use your data in a manner that is appropriate considering the basis on which that data was collected, as set out in the table at the top of this policy.

For example, we may use your personal information to:

- reply to enquiries you send to us;
- where you have specifically agreed to this, send you marketing communications by email relating to our work which we think may be of interest to you.

3. When we share your data

We will only pass your data to third parties in the following circumstances:

- you have provided your explicit consent either directly or via a third party for us to pass data to third parties;
- we are using a third party purely for the purposes of processing data on our behalf and we have in place a
 data processing agreement with that third party that fulfils our legal obligations in relation to the use of third
 party data processors; or
- we are required by law to share your data.

In addition, we will only pass data to third parties outside of Guernsey where appropriate safeguards are in place as defined by Section 56 of the Data Protection (Bailiwick of Guernsey) Law 2017.



4. How long we keep your data

We take the principles of data minimisation and removal seriously. We shall retain personal data for up to a maximum of 6 years, usually 3 years for insurance purposes.

5. Rights you have over your data

You have a range of rights over your data, which include the following:

- Where data processing is based on consent, you may revoke this consent at any time and we will make it as
 easy as possible for you to do this (for example by putting 'unsubscribe' links at the bottom of all our
 marketing emails).
- You have the right to ask for rectification and/or deletion of your information.
- You have the right of access to your information.
- You have the right to lodge a complaint with the Data Protection Commissioner if you feel your rights have been infringed.

Please note that relying on some of these rights, such as the right to deleting your data, will make it impossible for us to continue to deliver some services to you. However, where possible we will always try to allow the maximum access to your rights while continuing to deliver as many services to you as possible.

6. Cookies & usage tracking

A cookie is a small file of letters and numbers that is downloaded on to your computer when you visit a website. Cookies are used by many websites and can do a number of things, eg remembering your preferences, recording what you have put in your shopping basket, and counting the number of people looking at a website.

Where cookies are used to collect personal data, we list these purposes in section 1 above, along with other personal data that we collect. However, we also use some cookies that do not collect personal information but that do help us collect anonymous information about how people use our website. We use Google Analytics for this purpose. Google Analytics generates statistical and other information about website usage by means of cookies, which are stored on users' computers. The information collected by Google Analytics about usage of our website is not personally identifiable. The data is collected anonymously, stored by Google and used by us to create reports about website usage. Google's privacy policy is available at http://www.google.com/privacypolicy.html.
